The PRUventorTM Foam Heel Off-loading Device is for non-ambulatory patients only and should be removed before ambulation. Do not allow your patients to stand or walk while wearing the boot.

- **3.** Position the patient's foot inside the boot, with the heel suspended over the heel opening.
- Feed the straps through the D-ring buckles and secure hook closures.
- **5.** Visually check to ensure the straps do not restrict the patient's circulation.
- 6. To help prevent hip/foot rotation, remove the adhesive backing from the foam block insert and place on the medial or lateral side of the boot.
- 7. The patient's skin should be assessed frequently and the boot should be removed and placed back on the patient as specified by hospital policies and procedures. NOTE: Perform periodic skin assessment as specified by hospital policies and procedures.


